

<u>G5-1</u>	Case 1 – Isolated Substation – Totally Non Fire Rated Industrial and Commercial Areas
<u>G5-2</u>	Case 2 – Isolated Substation – Open Top, Non Fire Rated Doors – 2 Hr Fire Rated Walls – Industrial and Commercial Areas
<u>G5-3</u>	Case 3 – Adjacent Substation – Totally Non Fire Rated – Industrial and Commercial Areas
<u>G5-4</u>	Case 4 – Attached or Adjacent Substation Non Fire Rated Doors and Vents 2 Hr Fire Rated Walls and Roof – Industrial and Commercial Areas
<u>G5-5</u>	Case 5 – Indoor Substation with Public Access Over – Industrial and Commercial Areas
<u>G5-6</u>	Case 6 – Isolated Substation Totally Non Fire Rated (Up to 1000kVA) – Residential Areas
